Dear Mr. Rogge and Mr. Furlong,

Re: August 9, 2008 comments of Richard Pound in La Presse Newspaper

On August 9, Richard Pound provided the following colonial and racist remarks during a La Presse interview when asked about the potential embarrassment of holding the Olympic Games in China, with China's human rights record: "We must not forget that 400 years ago, Canada was a land of savages, with scarcely 10,000 inhabitants of European origin, while in China, we're talking about a 5,000-year-old civilization." Mr. Pound's remarks are highly offensive, hurtful and unacceptable to the Aboriginal people of Canada.

According to the Olympic Charter, the goal of the Olympic Movement is to contribute to building a peaceful and better world by educating youth through sport **practiced without discrimination of any kind** and in the Olympic spirit, which requires mutual understanding with a spirit of friendship, solidarity and fair play. Clearly Mr. Pound's statements are in clear contravention of the Olympic Charter which he is expected to promote and uphold as a member of the International Olympic Committee (IOC) and a board member of the Vancouver Olympic Organizing Committee (VANOC).

There has been ample time for Mr. Pound to apologize for his remarks. However, the only clarification issued to date has been Mr. Pound's comments that his statements were taken out of context. We find his silence and unwillingness to apologize very telling as he is clearly standing by his offensive position. We also note, that in February of 2007 the IOC ethics committee recommended that Mr. Pound exercise greater prudence in his public pronouncements following inaccurate and damaging statements regarding doping in the Tour de France. Clearly Mr. Pound's latest statements have shown his complete disregard for the IOC's Ethics Committee recommendations.

In the complete absence of any apology from Mr. Pound for his unacceptable and offensive remarks and given his past track record, we cannot see how he can continue to work under the Olympic Charter and maintain his positions within the Olympic family. We therefore call on you for the immediate removal of Mr. Richard Pound from both the IOC and VANOC.
